# ITEM 1 WELCOME

# ITEM 3 MINUTES OF FEBRUARY 27, 2020 MEETING

Motion to approve by Shelly Long, supported by Edith Suttles to accept the minutes as presented. Approved Unanimously.

# ITEM 4 REGIONAL CTE - FEDERAL PERKINS GRANT 2020-2021

Jennifer Branch and Jamie Engel provided overview of Perkins Grant, as well as what that will mean for regional students. The purpose of the Perkins Act is to allow secondary education students to develop not only academic knowledge but technical and employability skills as well. Perkins V grant funding will allow students to receive credentials for their competencies of academic and technical programs. Career coordinators in the region will work collectively with students to create after high school career and college pathways by connecting students with business and industry partners.

# ITEM 5 UPDATES FROM CAMW!

Edee updated the council on the CEO position and informed that Carrie Rosingana's CEO contract was approved by the Administrative Board in May. Edee is very thankful for the relationships that has been forged within T3 and hopes that these relationships only continue to build on the momentum with Carrie as CEO. CAMW! has drafted a COVID-19 Re-Engagement Plan that is nearing completion and comments are being collected. The plan has been circulated through the CAMW! system and shared with the CAMW! Administrative Board and Workforce Development Board. Carrie discussed how she had taken part in the Lansing Regional Chamber of Commerce's RELAUNCH Greater Lansing Task Force to help create a regional Resource Guide for Ingham, Clinton, Eaton, Shiawassee, and Livingston Counties businesses to utilize to support re-opening. This group included medical professionals, business owners, and local officials from Clinton, Eaton, Shiawassee and Livingston counties to represent the region as outlined in Governor Whitmer's MI Safe Start Plan. Edee and Carrie had Michigan State University's Global Youth Advancement International Studies and Programs reach out to them in regard to opportunities for CAMW! to partner on a variety of workforce development projects to support youth

engaged within these programs. Further opportunities for collaboration will be discussed in the months ahead.

#### ITEM 6 T3 PROGRAM UPDATES

- a) <u>MICQCA</u> Jay Moore informed that the MiCareerQuest Capital Area has been cancelled due to COVID-19. This was done after much discussion with the T3 Council leadership.
- b) <u>MINI EVENTS</u> Jay Moore gave an update that he is working with different organizations on hosting mini events on a virtual platform in order to still foster energy and momentum despite MiCareer Quest Capital Area being cancelled for 2020.
- c) <u>OTHER</u> Jay Moore discussed that he had a student from the MSU International Studies Fellowship program (Ines) working closely with him on planning the MICQCA event and all of the hard work she provided this year will support the 2021 MICQCA event. T3 is very thankful for all of the work that Ines did and wishes her well as she returns home.

#### ITEM 7 T3 STRATEGIC PLANNING SESSIONS

The strategic plan draft was distributed to the T3 Council to review and provide comments on. Teresa commented on the content of the strategic plan and asked if this format would be used for a springboard toward creating a regional talent map. Arnold asked what happened with the T3 Asset Map Committee and hoped those resources could be utilized to support the strategic plan. Michele informed that a while back there were asset maps created and discussed intersection with Jay LaNew from CAMW!, who is the Apprenticeship Liaison. Carrie and Jay would need to do more research on what happened to the asset map(s) created by that committee to determine relevance and accuracy for strategic planning purposes. The strategic plan will be in review and open for comment until prior to the next T3 Council meeting. Will plan to allow for continued discussion at the next meeting.

#### ITEM 8 OTHER BUSINESS

Jay Ediger provided an overview of the work that Junior Achievers is doing, including a tour of the website through screenshare. He informed on how Junior Achievers will deliver their career fairs virtually, as well as explored different sections of the website that allow different ages to explore careers through six engaging focus areas. He continued to invite the educators to utilize JA's website with their students and encouraged them to reach out to establish partnerships.
